1. Gold Plate Awards

A Gold Plate finalist will be judged several times by an independent, anonymous judge who travels the state to judge finalists in their category.



2. Chef of the Year

Chefs from WA's top establishments battle it out in the ultimate cook off. The event is held over several days with heats and finals to determine the top chef in WA.



3. State Student Waiter of the Year
